November 2018 Wagoner County Spring Junior Livestock Show Rules

Rules and Regulations

- 1. The Wagoner County Junior Livestock Board has adopted The IAFE Show Ring code of Ethics and has final say.
- 2. Exhibitors must be scholastically eligible for their animal to show.
- 3. Barn will be open at 12:00 p.m. Friday for Market Lambs, Market Goats and Doe Goats. All Lamb/Goat entries must be weighed and in place by 4:00 p.m. Friday. Lamb/Goat show will begin at 5:30 p.m. or immediately following the Celebrity Showmanship beginning at 5 p.m.
- 4. Weigh in for Market Hogs will begin at 6:00 a.m. on Saturday. All Market Hogs must be weighed in by 7:00 a.m. Market Hog Show will begin at 8:00 a.m.
- 5. Registration papers will be checked for Heifers and health papers will be checked for all cattle at 4:00 p.m. on Thursday. Cattle show will start at 5:30 p.m.
- 6. Ribbons will be given $1^{st} 8^{th}$ place.
- 7. First Place Winners in each breed class will compete for Breed and Reserve Breed Champion in Heifers, Goat, Hogs and Lamb divisions. Breed Champions will compete for Grand Champion.
- 8. Exhibitors may use WOOD CHIPS ONLY!!!!
- 9. Exhibitors cannot exhibit more than Three Heifers, Three Steers, Three Market Hogs, Three Lambs, Three Market Goats and Three Doe Goats.
- 10. All Major breeds will be recognized.
- 11. No unauthorized exhibitor can spend the night in the show barn. Lights out thirty (30) minutes following end of show and barn closed.
- 12. Livestock committee will divide classes and make the final decisions in regard to classing animals (breed, weight, age, size, etc.).
- 13. A \$10.00 entry fee per animal is due at the time of nominations. No late entries will be accepted. No postdated checks accepted. Entry fees are nonrefundable.
- 14. All animals must be exhibited in the Breed of Division they are nominated in unless changed by show officials.
- 15. Official health certificates must accompany all animals. All health certificates must have been issued within 30 days of the show and made available upon the request of any show official.

- 16. All animals must have a Muskogee or Oklahoma City tag from the nomination process at Porter or Coweta to show at the Wagoner County Junior Livestock Show. **NO EXCEPTIONS**.
- 17. All exhibitors must be currently enrolled in either Coweta or Porter 4-H or FFA Chapter to be eligible to show. Enrollment will be checked when animals are nominated. Exhibitors must be 8 years of age and in the 3rd grade by September 1, 2018. Exhibitors must not have graduated High School.
- 18. All exhibitors participating in Showmanship Classes must show their own animal. Exhibitors may show in each division that has a Showmanship Class.
- 19. There will be a Showmanship division in each species and provided there is at least one exhibitor in an age division which has a Showmanship Class.

BEEF, LAMB, GOAT & HOG SHOWMANSHIP DIVISIONS: Sr. Division: 16-18 years. Intermediate Division: 13-15 years. Jr. Division: 9-12 years.

(Exhibitor's age the day of the show.)

- 20. All animals will be released upon completion of their respective shows; however, all animals making the sale must be back in the barn by 4:00 p.m. Saturday.
- 21. Exhibitors must wear the appropriate clothing for the organization that they represent, with an official emblem of at least 2 ½". Exhibitors must follow the dress code in order to show and participate in the Premium Auction. (FFA members must wear their FFA jacket.)
- 22. No drug of any kind will be permitted to be given to an animal while on the fairgrounds unless it is approved by and in attendance of Show Officials and/or a veterinarian.
- 23. All animals in the Premium Auction will be assessed the cost of two (2) photos, one to be presented to the buyer of the animal and one to be given to the exhibitor.

 The cost will be deducted from the premium money.
- 24. Only designated personnel selected by the show committee will be allowed to work show ring and the premium sale. Violations may result in disqualification.

- 25. Any protest must be filed with the Show Officials NO later than 30 minutes after the judging of the respective division and must be submitted in writing including a \$100.00 deposit. In the event of a valid protest, the \$100.00 will be returned to the protester. If the protest is not valid the money will be forfeited and the decision of the show officials will be final.
- 26. Criticizing or interfering with the Judge, Show Officials, or Exhibitors and other conduct detrimental to the show may result in disqualification of the Exhibitor.
- 27. Animals must be owned by the Exhibitor(s) by time of nominations, with the exception of family nomination residing in same residence.
- 28. Exhibitors will be assigned pens. Exhibitors must clean their stall (wood chips, hay trash etc.) prior to receiving any money or awards.
- 29. Any Exhibitor and/or animal has shown or participated in another Wagoner County Spring Livestock Show this calendar year which has a bonus or premium auction, is ineligible to participate in the Wagoner County Junior Livestock Show. Any violation will result in forfeit of premium.
- 30. All questions in dispute or difference not covered by these rules will be referred to the Show Board whose decision shall be final.
- 31. NO SMOKING ALLOWED IN THE BARNS.
- 32. ALL 4-H AND FFA MEMBERS MUST ACT BECOMING TO THEIR ORGANIZATION.
- 33. Any Exhibitor who has more than one animal in the show ring at once, the second animal must be shown by an eligible 4-H or FFA member.
- 34. Students will be allowed to enter and show any animal nominated by an individual from their household according to the following restrictions: The students must all legally reside in the same household and share the same legal address. The student who is entering the animal must have materially participated in the care of the project.
- 35. Adhesives, including paint, are prohibited on all species.
- 36. Livestock exhibitor must show his/her own animal(s).
- 37. Substitution exhibitor will only be allowed if original exhibitor is missing for a school sponsored activity. Substitution order will be family exhibitor, then community exhibitor, then county exhibitor. Substitute exhibitor must be approved by WCJLS board.

BEEF DIVISION:

Market Steers:

- 1. Minimum weight of 800 pounds.
- 2. No artificial pumping in the barn.

REGISTERD HEIFERS

- 1. Registered papers must be in Exhibitors name.
- 2. Papers will be checked at check-in time.
- 3. Open to all recognized breeds.
- 4. Heifers show by age within their Breed, Breed Champion will show against all Breeds for Grand Champion.
- 5. All registered heifers must have been calved after January 1, 2017.
- 6. No artificial pumping in the barn.
- 7. All registered heifers must have healed tattoos or fire brands that correspond with papers at check-in time.

COMMERCIAL HEIFERS

- 1. The two center permanent incisors may be in but no other permanent incisors may be visible. If either of the 2 center permanent incisors are above the cutting edge of the adjacent temporary incisors, the heifer must be verified pregnant by licensed veterinarian or have calf at side. Final decisions left to the official veterinarian.
- 2. Heifers will be shown by weight only.
- 3. Heifers may not be shown in both Registered and Commercial classes.
- 4. No artificial pumping in the barn.

SWINE DIVISON:

Market Barrows and Gilts:

- 1. Minimum weight is 180 pounds. Maximum weight 300 pounds.
- 2. Market Hogs will be shown by Breeds.
- 3. Breeds are: Berkshire, Chester, Duroc, Hampshire, Hereford, Poland, Spot, Yorkshire and Crossbreds.
- 4. NO SNARING OF HOGS ALLOWED.
- 5. No artificial filling will be allowed in the barn.
- 6. All Hogs must have a pseudo rabies-brucellosis test taken after December 1, 2018 or originate from a qualified herd.
- 7. No artificial coloring.

SHEEP DIVISION:

Market Wethers and Ewe Lambs

- 1. Minimum weight is 70 pounds. No maximum weight limit.
- 2. All sheep will be slick sheared.
- 3. NO DRENCHING ALLOWED IN THE BARN.
- 4. Lambs will be shown by Breeds.
- 5. Breeds are: Dorset, Hampshire, Natural, Shropshire, Suffolk, Southdown and Crossbreds.

GOAT DIVISION:

Market and Doe Goats

- 1. Minimum weight 40 pounds. No maximum weight limit.
- 2. Goats will be shown by weight.
- 3. NO DRENCHING ALLOWED IN THE BARN.

Selection of Sale Order

All Grand Champions automatically make the Premium Sale. All Grand Champions must sell. No one can have more than one (1) animal in the Premium Sale, unless they are Grand Champions.

STEERS

Grand Champion Steer automatically will make the Premium Sale. All other Steers will show for sale order.

HEIFERS

Grand Champion Heifer automatically will make the Premium Sale. All other Heifers will show for sale order.

SHEEP

Grand Champion and Reserve Champion Sheep will automatically make the Premium Sale. All other Sheep will show for sale order.

SWINE

Grand Champion, Reserve Champion Swine and Breed Champions will automatically make the Premium Sale. All other Swine will show in breed for sale order.

MEAT GOATS AND DOE GOATS

Grand Champion Market Goat and Grand Champion Doe Goats will automatically make the Premium Sale. The number of other Goats that make the Premium Sale will depend on how many goats are shown.

Selection Formula:

Fifty (50) head will be selected for the Premium Sale plus or minus three (3).

All other animals will be selected by the Judge according to the quality and /or market readiness regardless of Breed or placement during the show.

At the completion of Sale Order for Swine, Exhibitors must notify Show Officials within thirty (30) minutes which animal is to be in the Sale Order. If the exhibitor fails to do so, Show Officials shall select the animal to be placed in the Sale Order. This rule will be strictly enforced!

The Board will no longer bill companies or individuals for add-on money. ALL ADD-ON MONIES MUST BE RECEIVED WITHIN ONE WEEK OF THE PREMIUM SALE OR WILL BE FORFEITED!
